





Power consumption chart for appliances

Home appliances vary significantly in their power consumption. Factors like appliance type, usage patterns, and energy efficiency all play a role in determining how much electricity they use. Generally, appliances like refrigerators, air conditioners, water heaters and heating appliances tend to consume the most energy in a household.
